NOTICE IS HEREBY GIVEN that a Petition has been presented to the High Court by the directors of AmTrust International Underwriters Designated Activity Company (the "**Transferor**") seeking the sanction by the High Court pursuant to the provisions of Section 13 of the Assurance Companies Act 1909 (as amended), Section 36 of the Insurance Act 1989 (as amended) and Regulation 41 of the European Union (Insurance and Reinsurance) Regulations 2015 (as amended), for the transfer of insurance business of the Transferor to AmTrust Assicurazioni Società Per Azioni (the "**Transferee**") pursuant to the terms of a scheme filed with the High Court (the "**Scheme**"), together with ancillary relief. The effective date of the Scheme being sought from the High Court is expected to be 1 April 2026 at 01:01 (Italian time).

By Order of the High Court dated 17 December 2025, it was directed that the Petition be listed for hearing on Tuesday, 24 March 2026 at 11.00 a.m. (Irish time) before the High Court, the Four Courts, Inns Quays, Dublin 7, Ireland and that any person who may be entitled to be heard may appear at the time of the hearing in person or by Counsel or by Solicitor.

Any interested party who intends to appear at the hearing of the Petition should notify the Petitioners' solicitors, William Fry LLP, 2 Grand Canal Square, Dublin 2, D02 A342, Ireland (quoting reference 029510.0002.EDC/NCA/RJR) in writing no later than 5.00 p.m. (Irish time) on Friday, 13 March 2026 of that party's intention to appear at the hearing of the said Petition and should indicate to the said solicitors whether such party intends to support or oppose the said Petition. Any such notice of intention to appear should be signed by that person or persons and should contain the address of that person or persons or their solicitors. Any person having delivered a notice of intention to appear at the hearing who intends to oppose the Petition should set out on affidavit the basis for such opposition and such affidavit should be filed in the Central Office of the High Court in Dublin and served upon William Fry LLP at the address above by no later than 5.00 p.m. (Irish time) on Friday, 13 March 2026.

together, the "**Transfer Documentation**".
